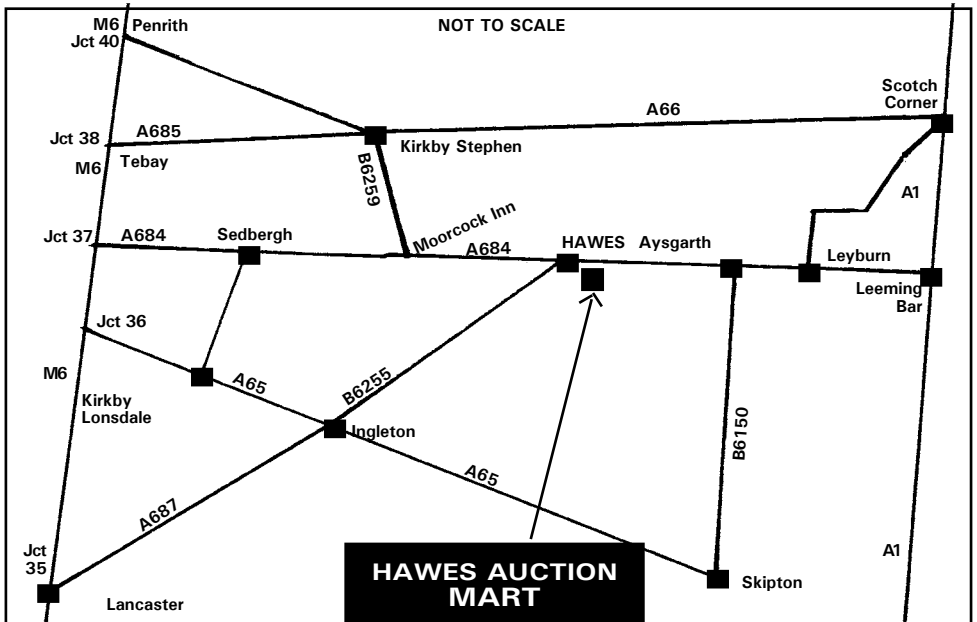

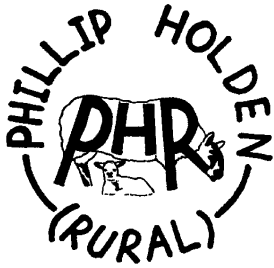
N.E.M.S.A. SALE RULES

1. Lambs presented at Association Sales must be the bona fide property of members.
2. They must be sired by a pure Blue-faced Leicester ram, out of either a Swaledale or Northumberland-type Blackface ewe.
3. At Association Sales, all lambs forward will be subject to the scrutiny of inspectors.
4. Any member whose stock is deemed to be of incorrect parentage, will be warned in writing the first year, then if there is no improvement the following year, their membership will be terminated.
5. There shall be no black lambs.
6. Lambs sold at Association Sales will be subject to whatever levy is in force at the time.
7. Any dispute arising as a result of these rules will be settled with the Council of Management.
8. The UK Flock number precedes the member's name.
9. All members' lambs must be tagged, any members' lambs found to be untagged will be automatically transferred to the end of the Association sale to be held in 2020.
10. Vendors should not use coloured yarn in the identification of lambs.

These rules do not invalidate existing Auction Mart Company rules.

PLEASE BE AWARE: TAGGING REGULATIONS REQUIRE ALL LAMBS PRESENTED AT THIS SALE TO BE DOUBLE TAGGED, ONE ELECTRONIC TAG AND ONE MATCH UP PLASTIC TAG.

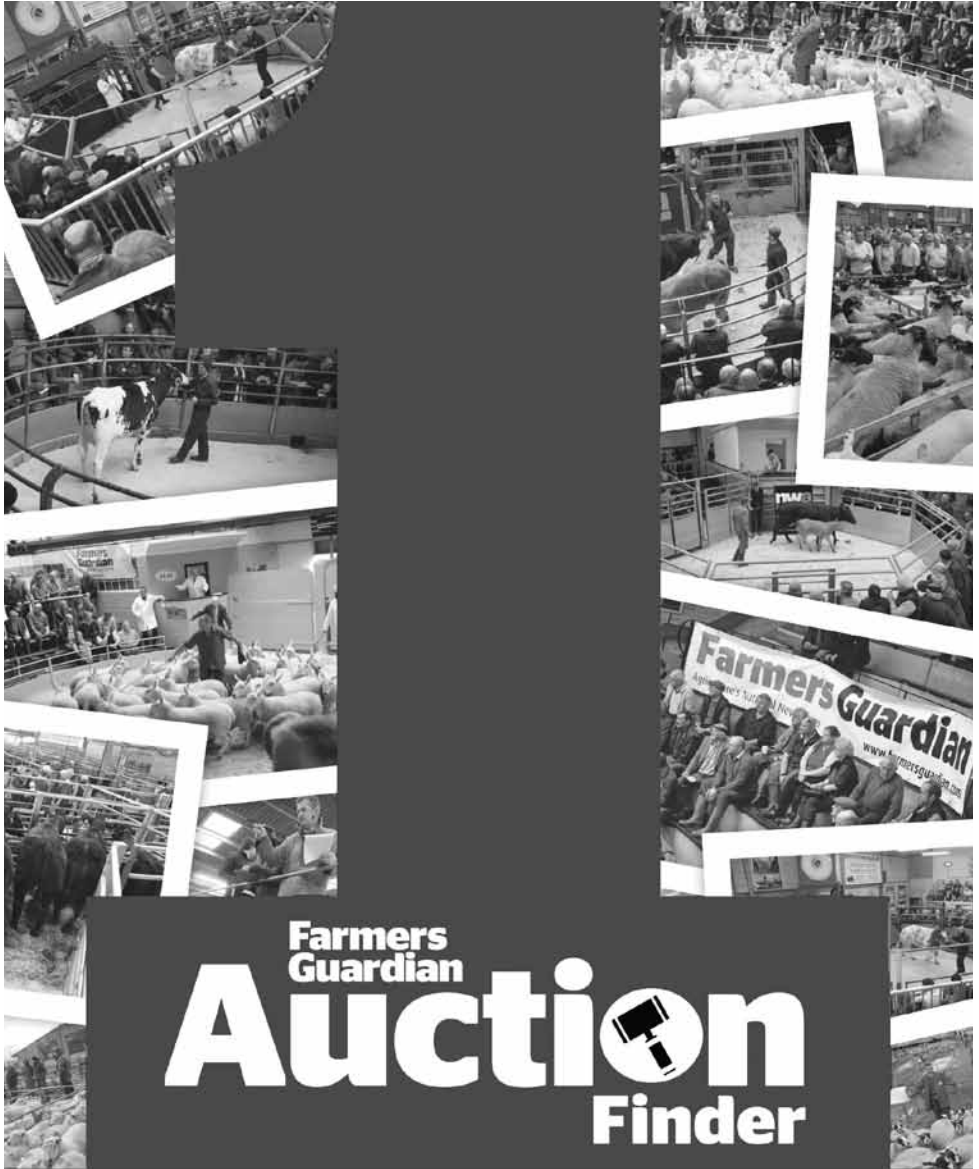
